| <p>Paycheck Protection Program</p> | <p>https://www.sba.gov/funding-programs/loans/coronavirus-relief-options/paycheck-protection-program-ppp</p> | <p>The Paycheck Protection Program is a loan designed to provide a direct incentive for small businesses to keep their workers on the payroll. SBA will forgive loans if all employees remain on the payroll for eight weeks, and the money is used towards compensation, rent, mortgage interest, or utilities.</p> | <p>This program is for any small business with less than 500 employees (including sole proprietorships, independent contractors, and self-employed persons), private non-profit organizations, or 501(c)(19) veterans organizations affected by coronavirus/COVID-19.</p> |
| <p>Disaster Loan Assistance</p> | <p>https://covid19relief.sba.gov/#/ https://covid19relief.sba.gov</p> | <p>In response to the Coronavirus (COVID-19) pandemic, small business owners in all U.S. states, Washington D.C., and territories are eligible to apply for an Economic Injury Disaster Loan advance of up to \$10,000. The loan advance does not have to be paid back.</p> | <p>Businesses with less than 500 employees, Sole Proprietorships, Independent Contractors.</p> |
| <p>Express Bridge Loan Pilot Program</p> | <p>Find an Express Bridge Loan Lender by connecting with your local SBA District Office</p> | <p>Express Bridge Loan Pilot Program allows small businesses who currently have a business relationship with an SBA Express Lender to access up to \$25,000 with less paperwork. These loans can provide vital economic support to small businesses to help overcome the temporary loss of revenue they are experiencing and can be a term loan or used to bridge the gap while applying for a direct SBA Economic Injury Disaster Loan.</p> | <p>If a small business has an urgent need for cash while waiting for decision and disbursement on Economic Injury Disaster Loan, they may qualify for an SBA Express Disaster Bridge Loan.</p> |
| <p>Unemployment Insurance</p> | <p>Contact your State Unemployment Dept. Google: (enter your state) followed by unemployment. <u>Example:</u> CA unemployment</p> | <p>The federal government is allowing new options for states to amend their laws to provide unemployment insurance benefits related to COVID-19. Federal Government to give an extra \$600 per week to State unemployment amount as well as an additional 13 weeks of benefits.</p> | <p>If you are self-employed and gig workers, reduced hours, reduced wages, unable to work due to mandated business closure, unable to work out of fear of exposure.</p> |

| Delay Sales Tax Payments | NOTE: The link below applies to California only. If you are in another state, you must refer to your state's website for resources. https://onlineservices.cdtfa.ca.gov | California sales and use tax filers have a 60-day extension on their time to file and pay sales tax. The measure also provides some stress relief to California taxpayers who inadvertently find themselves filing and paying late. California allows you to request the extension, even if you are already late with your filing/payment. |
